From The Mayor's Desk

As I sit here today writing to you, it has been just 56 days since I raised my right hand and took my oath of office to be your new Mayor, and I have to say that the experience has been amazing. We have a fantastic Town Council that focuses on the Town's best interests and moving us forward. Thus far, it has been a privilege to work with a fantastic group of people who share a collective interest in prospering the Town. It definitely makes my job as Mayor a little easier when I have a group of people willing to work with me.

The month of April was a busy month. First, we hired a new Town Attorney, Mr. Patrick Kennedy. My Kennedy has been a long-time resident of Putnam County and this area. He has worked both in Putnam County Government and several years ago for the City of Crescent City. He brings both a knowledge of the Law and a unique perspective being in previous governmental roles. I have negotiated a contract with Mr. Kennedy that the Welaka Town Council recently approved, giving us a flat rate each month instead of being billed by the hour. This is vital because we are updating the Town Ordinances, Charter, and codes, and zoning. The amount of work is daunting, and if we were to be instead billed by the hour for his services, it could easily double or triple the rate he is charging us.

This brings me to my next point, and that is our Town Ordinances. We have approximately 50 Town Ordinances. Many of which have not been updated since the 1960s and need significant work. At our next regularly scheduled Council Meeting on May 11th, we will discuss the ordinances and assign each Councilmember one ordinance to work on individually with the assistance of our Town Attorney. This will allow the Town Council to cover more ground and get our ordinances up to date more quickly.

We, the Town Council, also have a significant decision to make in the coming weeks concerning the appointment of a new Town Councilmember to replace the vacancy left on the Council by the passing of Councilman Washington. On May 6, 2021, at 5:30 PM, the Welaka Town Council will be holding a special called Council Meeting at Welaka Town Hall located at 400 4th Ave. Welaka, Fl. 32193 to interview prospective candidates for the position. As your Mayor, I implore you to please come out that night and join us for that meeting as we are planning to make a selection that night to fill that position. This is your Town Government. I encourage you to be a part of it by being at that meeting.

On a community note, we also have some exciting things happening in River Hill Subdivision, located just above Welaka Villages on CR308B. Right now, we have nine new homes under construction in the subdivision and nine new permits being pulled for a total of eighteen new homes to be added to the Town of Welaka in the next 12 months. These are exciting times for Welaka. We see healthy growth that will benefit our community and expand our tax base. I am also pleased to say that Welaka Town Council has approved me to plan a 4th of July parade for the Town. We plan to have a parade and a community event similar to Welaka SpringFest but located at Downtown Park. Right now, the planning is still early on. I will be releasing more on our Town Facebook Page and Website and will have all the dates and list events scheduled for that day in the Junes Newsletter.

In closing, I want to thank you again for the trust you have placed in me to be your Mayor. I take my responsibility very seriously and will continue to work hard every day to make sure Welaka is a little bit better than it was the day before.

A Moment In History



Last month we briefly shared with you the history of the Bryant family who founded the Town of Welaka. We also shared the part of Octavia (Tivie) Bryant Stephens, the daughter of James Bryant, the founder of our Town. In the picture, you see Octavia's daughter Rosalie on the right side of her. We recently visited Greenwood Cemetery in Welaka and found the graves of both Octavia and Rosalie. Octavia suffered many heartaches during her time in Welaka, including the death of her husband and mother just a few days apart. I will leave you with an expert from Octavia's diary.

On Sunday, February 28, 1864, dear Mother was taken with a congestive chill. On Friday, March 4, 1864, Davis [her brother] came with the news of the death of my dear, dear husband. He was killed in battle near Jacksonville on March 1. Mother grew worse, and on Sunday, March 6, she was taken from us between 12 and 1 o'clock. She passed quietly away from Typhoid Pneumonia). At seven o'clock p.m. I gave birth to a dear little baby boy, which although three or four weeks before the time, the Lord still spared to me. Mother was buried on the 7th, and Rosa [her daughter] was taken with fever but recovered after two days. Davis returned to Lake City on the 10th, and Willie [her oldest brother] arrived here on the 12th, and he and Henry [a third brother] left today for Monticello, Willie going to



Lake City to see Davis, expects to return in a few days, our relatives and new-made friends have been kind in visiting, Aunt Julia has devoted nearly her whole time to us since the first day of Mother's sickness.

I have named my baby Winston, the sweet name of that dear lost one, my husband, almost my life. God grant that his son, whom he longed for but was not spared to see, maybe like him. I now begin as it were a new life. I pray that the Lord will give me strength to bear up under this great affliction, and with His help and the example of those two dear ones [her husband and second daughter

who died soon after birth] now with Him I may be enabled to do my duty in this life and be prepared when the Lord calls me to meet them in that "better world" where there will be no parting and no more sorrow.
