# **NEWSLETTER**

Again, we are questioning how that letter originated and why there substantiation approval. Nowadays, we still try to do the same thing. #### **PUBLIC RECORDS**



With much diligence and yet again we are requesting further review by the state. We feel that we do understand Public Records. Perhaps some of you in the public do not. We live in a modern world of almost instant correspondence. With Social Media, Facebook and other items, the printed paper once a month doesn't keep quite up to the speed daily of some of the goings on of various modern abilities. However, here is what it boils down to for you. Not only is what's in Town Hall records public, but you will enjoy using Social Media, I.E. coming along by internet. What arrives here becomes Public Record. So not only

are we responsible to all when various members of the community send us emails. Be careful and recognize the fact that your email becomes Public Record once sent to Town Hall. Many loopholes, not necessarily allowing your product to be silenced within the Town Hall. The public can know if they so desire of what you are sending to us.

Over the years that I've served, we have had at least four wonderful Town Clerks previously to current situations. We had a wonderful Clerk who was so intimidated by a certain member of the community, and his threats of personal lawsuits, that she did give up. A fantastic Clerk, but intimidated to death. What a loss it was. However, following that, we had a wonderful applicant that appeared from Orlando. She was in her late thirties and had just spent seven years with State's Attorney's Office in Orlando, she really knew Public Records. Same gentleman that had destroyed the other one now met an adversary who knew what she had to do in Public Records, and made sure that they were done, and would not be intimidated. She placed a sign behind the desk on the wall for all to read: "I cannot create to accommodate a Public Record that is not here. I cannot make it up to satisfy what you want it to say".

We are very fortunate that we had Judy Jones for many years, and that she trained Jennifer McDaniel very well. You may not like the message when you leave Town Hall, but very seldom have I ever heard a complaint against the messenger. Our staff really tries to support the Town in its entirety and fairly. To this day we try and keep our Newsletter upbeat. We gave you

the truth. We do like to encourage happiness. We do want you all to study a little bit of history. Don't be here a couple of years, and not check about the people that were here for a couple of hundred years before you, and what they have done. We are proud of the fact that we can retain some of our simpler forms of enjoyment.

If you weren't happy where you were, you probably won't be happy here because basically we all try to protect and take care of each other. We have survived many communities nearby. Remember, Welaka is still here. The river will still be here after we're gone. We attempt to enjoy it in a manner without totally destroying it. Many of you spend weekends here, many of you use this as a second home. and when I ask the majority of you all to tell us, it is the quiet and laid back life and enjoyment here in Town that keeps you here.

# **RUMORS**



As we progress throughout this year, we're going to be very careful. Let's makes sure that some of the false rumors that hurt us that are currently floating around Town do not continue to multiply. The situation recently was thrown upon the public by Social Media as well as the Internet and emails to the Town Hall. This is one thing I wish that every one of you would remember and tell your neighbor, the Town of Welaka's Utility System is not controlled by The Public Service Commission. Municipalities are very clearly outlined in Florida law that they are not under the control of a Public Service Commission. If you

don't believe this and you believe what is being spread, that we are under PSC control, you have been sadly misinformed. We can take complaints all day long and if you can show that they apply to us, but don't take a law from the State of Florida that has no jurisdiction whatsoever over this Municipality and try to beat us over the head with it.

Additionally, people that have been here many years or very few years, if you have a problem with your plumbing, check it out. In the early nineties when we went from undrinkable and unusable water, to a drinkable Town Water System, there were situations that were brought to everybody's attention. One of the things that we advised everybody, when you hook up from the meter to your house, those of you that have had gray poly pipe up to this point, make sure you no longer use this product today. Some complaints do not realize the history of the property they've bought. Certain situations were created by you, by previous homeowners, not us. I mean, very simply put, there's a rule that after discussing with our Engineer, the Water Tower is so many feet above sea level. Certain points in the Town are at some other levels. There is no mechanical pumping from the Water Tower into the water main. It is a gravity fed system from the Water Tower where you don't have to be a genius to understand the rules of elevation and water pressure.

The condominiums have to have sufficient pressure, so it's water can reach the third floor. This was what was calculated in the original change over from private wells to community water service. Other matters continued to arise.

Certainly, your own doing should not affect the happiness of all the rest of the Town chain.

#### WHAT IS HAPPINESS?



Certainly, some of the things that have occurred this year and are continuing to show the heart of not only our Municipality, but many individuals in our community. We see a wonderful balance between various parties throughout Town who have no other thoughts than the betterment and the care of each other.

Programs for Child Care and Elders, care for those that are less fortunate. All of these, have people stepping forward. Truly, good individuals hearted banded together with others is what makes us the town we are. We bring to your attention that under much diligence Harriet Vanslyke has events, she has been able to gain a food distribution program for here in Town. Currently, there'll be a once a month situation. We will keep you apprised in the Newsletter. January will be the first month of distribution. We aren't we'll guaranteeing that completely smooth, but we have allowed the Town facilities to be used as it progresses here for January. We will put notices on the Town bulletin boards. Let's all help her and those involved to make this a monthly benefit. We truly miss Al Kaufman. It's been almost four years. He worked part time on various little jobs that helped beautify the Town. We miss him more and more as time goes on.

Currently, we have a part-time person that we're going to try and alleviate some of these situations with quite little pain done around Town. A little cleanup, just little things that make you feel a little more at home. Slightly prouder of being here in Town than you are in the County. This is what makes us feel good. Each and every one of the Town Staff has certain talents that they bring to their job. For the amount we spend on help, we gain greatly.

WHY DON'T WE HAVE A CITY MANAGER?



Your Council backs the Town Staff. If you feel like spending \$100,000 and can't find a City Manager, so be it. We seem to move along pretty well. Yes, there are some very talented people here in Town. I've listened to some of them. I've made some wonderful friendships over the last 25 years, wouldn't have traded it for anything.


- 15. <u>Audience Participation:</u>
